Per Minutes of Benchers' Meeting, September 23rd & 24th, 1993

- A member may apply by way of a letter to receive a pro-rated refund of the annual fee.
- For the purposes of pro-ration, the date considered will be the month following receipt of the application.
- The refund can be made payable only to the party who originally paid the annual fee.
- Only 1/2 (6 months) of the annual fee will be prorated.
- No applications will be entertained for the period of January 15 to March 15.
- Save in exceptional circumstances, application by members will be restricted to once in each fee year.
