The Law Society's mentorship programs (Mentor Express, Mentor Connect and Indigenous Mentorship Program) are hosted through a platform called **Mentorship Rocket**. You can access the 2025-2026 program at:


If you did not participate in Mentor Express within the past two program cycles, you need to create a mentee account by following the steps in the [Registration Guide for New Mentees](#).

The following steps detail how to re-activate your Mentorship Rocket mentee account.

1. Re-activate your previous login
 - a) Click **LOGIN**.

- c) Enter your password and click **LOGIN**

2. Review Mentee Registration Form

- a) The Mentee Registration Form page displays an informational video for your viewing.
