Secretary's note: Ms. James facilitated the virtual election and audit by the Voting Monitors in a separate Microsoft Teams meeting.

1. Call to Order and Adoption of the Agenda

Ms. Petriuk called the meeting to order at 4:03 p.m. The agenda was circulated with the materials prior to the meeting and adopted by consensus.

2. President-Elect and Potential Executive Committee Vacancy Election

Documentation was circulated with the materials prior to the meeting.

Ms. Petriuk announced that Mr. Melnyk was the only Bencher who put their name forward as candidate for President-Elect.

Ms. Petriuk read the election procedures and explained how the elections would be conducted anonymously through an electronic survey and verified. She called for nominations from the floor for President-Elect in accordance with Rule 27(1). There were no nominations from the floor and Mr. Melnyk was declared elected as President-Elect by acclamation, effective immediately.

Ms. Petriuk confirmed the four candidates who expressed their Statements of Intention to stand for election to the Executive Committee were Ms. Bourgeois, Mr. Matheson, Mr. Sorokin and Mr. Vogeli. There were no nominations from the floor. The nominations were declared closed, then Ms. Petriuk read the Executive Committee election procedures.
